**Student Financial Services FAQs**

1. **How much are Tuition and Fees?** The following are estimated costs per semester for full-time first-year students. Tuition and Fees can vary by student based on program and enrollment status.

2. **What are my payment options?** Saint Anselm College offers several payment options. To avoid late fees or interest charges, balances must be paid in full or covered by a Monthly Payment Plan by the due dates listed below.
- **One-time payment** can be made online using electronic check (no fees apply) or by credit card (subject to 2.75% Fee). Payment can also be made by cash or check.
  - **Monthly Payment Plans** allow you to spread your education expenses over five smaller monthly installments, which are paid over the course of the semester. The enrollment fee is \$50. Any outstanding balances covered by a Monthly Payment Plan are not subject to late fees or interest charges.
3. **When is tuition due?** The billing and payment schedule is as follows:

4. **How will I receive my bill?** Your bill will be received electronically. Please note that the College is in the process of transitioning to a new online student account platform called Nelnet. Additional information will be forthcoming. Please keep an eye on your Saint Anselm email for future communications.
5. **Do I need Medical Insurance?** It is a condition of enrollment that all full-time students have health insurance coverage. Please review the detailed information from Health Services. Additional email regarding waiving or enrolling in the College's insurance plan will be sent to students' anselm.edu email address in early June.
6. **Can I purchase Tuition Refund Insurance?** The College partners with GradGuard to provide Tuition Refund Insurance which can help refund your tuition, fees, and room/board charges, up to the policy limits, if you are unable to complete the semester due to a covered medical reason such as an illness, accident, or mental health issue. 7. **What forms need to be completed for Student Financial Services?**
- **Payment and Initial Disclosure Notice (electronic):** In accordance with the Federal Truth-in-Lending Act, Saint Anselm College is required to inform their students of the terms and conditions governing their attendance at the College. Please read the disclosures contained in this notice carefully. It must be signed by the student, and a parent or guardian by June 15, 2020.
  - **Federal Funds Authorization Form (electronic):** Although you may not currently be in receipt of federal financial aid, we ask that all students complete a Federal Funds Authorization Form once during their academic career at Saint Anselm College. Please complete by June 15, 2020.
